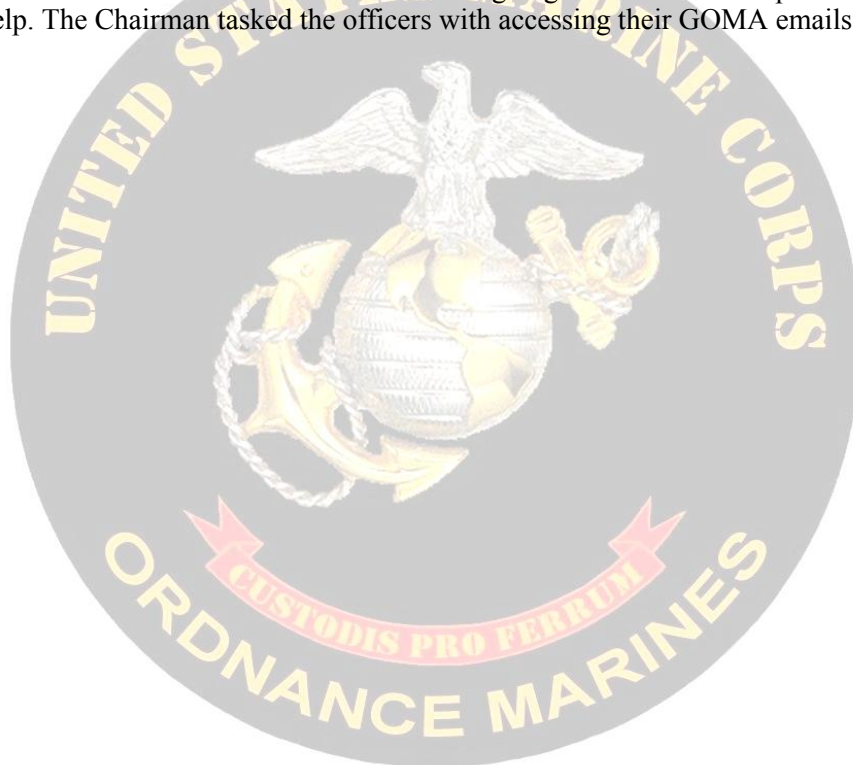
Meeting opened at 1630 (PST)

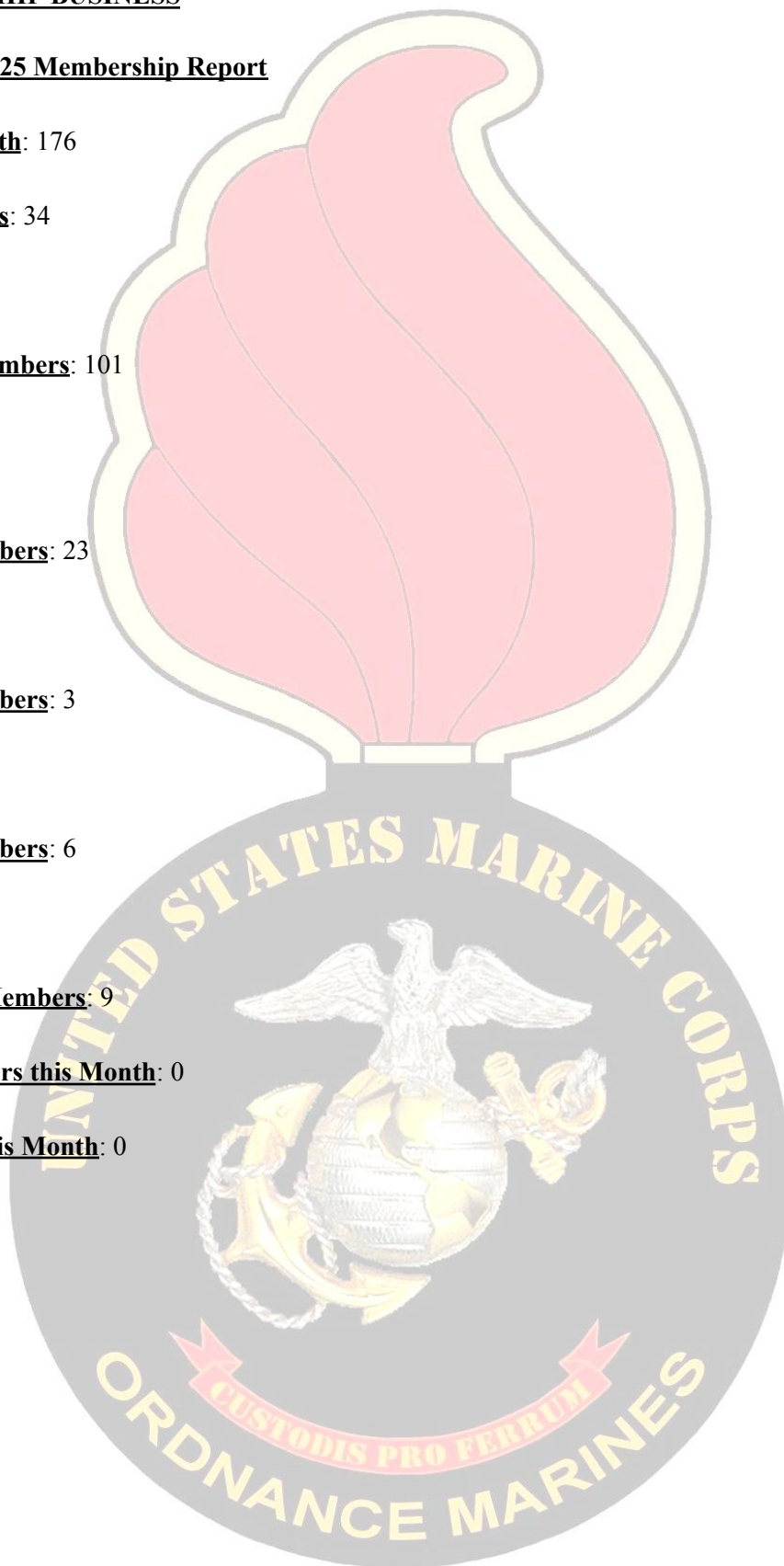
